**SAT Score Time Line**

The last date for receipt of SAT scores for DASA-2017 is as follows:

**22nd June 2017 for Round 1 and 2**

**13th July 2017 for Round 3**

**29th July 2017 for Special Round**

All the dates are as per Indian Standard Time (IST)

**Note:**

- New applicants (UG) are advised to send the SAT scores to VNIT (Institute code:7035) by the RUSH mechanism only. All Scores which are received before 23:59 HRS (IST) 22<sup>nd</sup> June, 2017 by DASA office will only be considered for the first two rounds. Applicants are requested to check their application home page on regular basis. No individual communication will be made.
- The payment should be made by new applicants as follows:
  - For CIWG category:** Prescribed tuition fee per year is Rs. 125000/- (Rupees one lakh twenty five thousand only). Applicants are required to pay Rs. 82,500 /- [ 50% of the tuition fee i.e., Rs. 62,500/- plus registration fee USD 300 (INR equivalent Rs. 20000/- only) ]. **The fees should be paid by NEFT/ RTGS only.** The scan copy of NEFT/ RTGS receipt is required to be uploaded in the online application.
  - For all other categories:** Prescribed tuition fee per year is USD 8000. Applicants are required to pay USD 4300 [50% of the tuition fee i.e., USD 4000 plus registration fee USD 300]. **The fees should be paid through e-payment by payment gateway only, which is provided in the online application portal itself.**

**In case, the payment does not reach to DASA-2017 account before the closing date due to any delay in the process, DASA 2017 will not be responsible and such applicants will not be considered for seat allocation.**
